The project site is served by an on-site septic system, service for water will be provided by San Joaquin County Water Works No. 2, and storm drainage will be provided by San Joaquin County Service Area No. 14. The hours of operation will be from 7:00 a.m. to 5:00 p.m., seven (7) days per week. The parcel will be accessed from E. State Route 12.
