The Visalia City Planning Commission will consider the following items on **Monday, April 13, 2020 at 6:00 p.m.**, at the **City Hall, Council Chambers, 707 W. Acequia Avenue, Visalia:**

- Zoning Text Amendment No. 2019-13: A request by CarMax to amend Zoning Ordinance Section 17.25.030 (Zoning Use Matrix Line A22) to establish "Car Sales – New & Used" as a conditional use in the C-R (Regional Commercial) District, Citywide and to amend Chapter 17.32 Special Provisions to establish Development Standards for Car Dealerships in the CR zone.
- Conditional Use Permit No. 2019-42: A request by CarMax to allow a used car sales and service center on a 5-acre parcel in the C-R (Regional Commercial) Zone District. The project site is located on the southwest corner of S. Mooney Blvd. and W. Visalia Parkway. (APN: 126-960-001)

Persons providing comments via telephone will still need to access the City's Facebook Live stream to observe the proceedings.

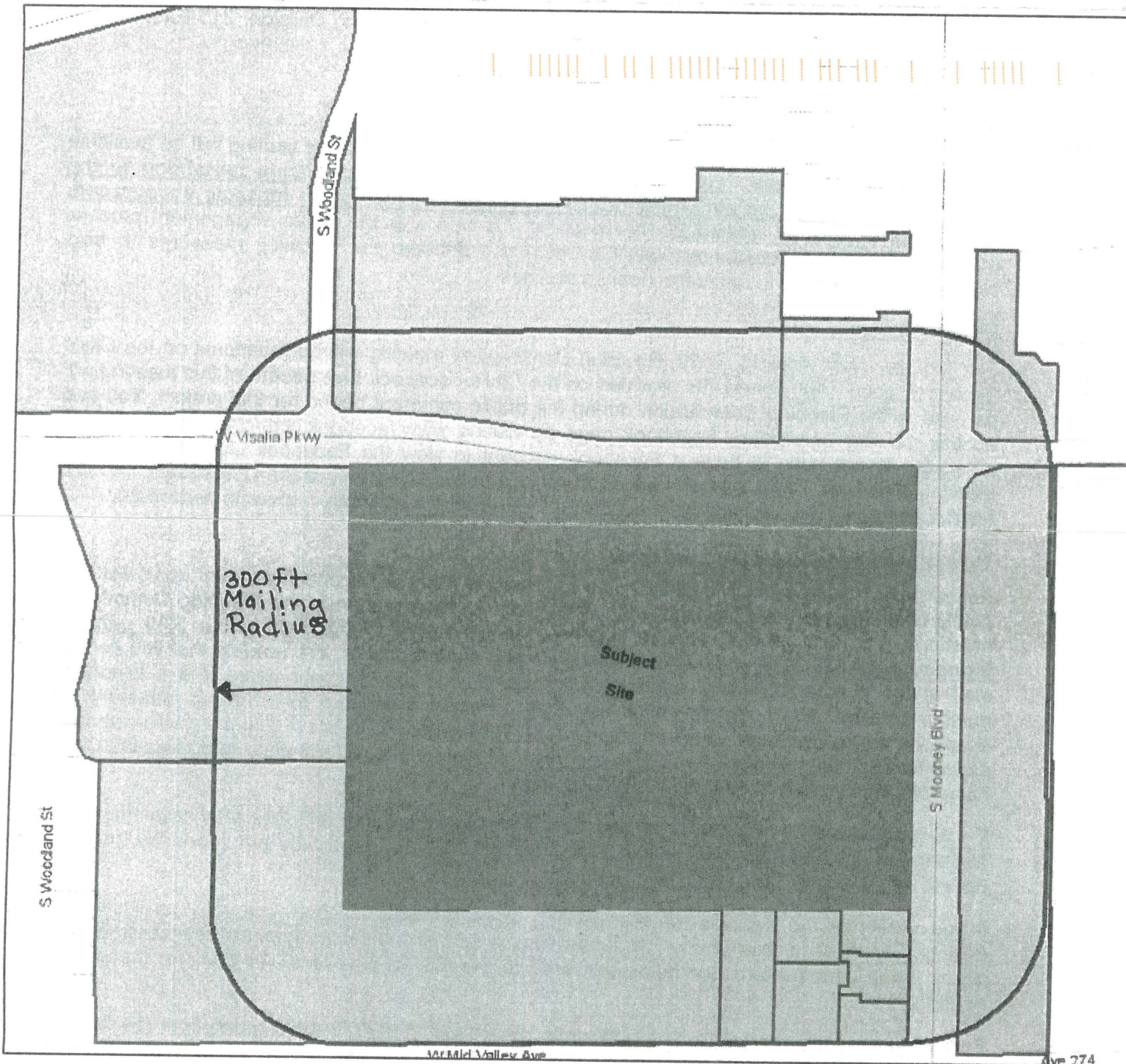
