- Tentative Parcel Map No. 2019-13: A request by Lars Anderson & Associates, Inc. to subdivide a 28.7 acre site into a 11-lot commercial subdivision in the C-R (Regional Commercial) Zone. The site is located on the southwest corner of S. Mooney Blvd. and W. Visalia Parkway (APN: 126-960-001).
- Conditional Use Permit No. 2019-31: A request by Lars Anderson & Associates to establish a master planned commercial development including the establishment of three retail buildings, a credit union building, a gas station/convenience store, a sit-down restaurant, two drive-thru restaurants, and an automotive tires and sales store, on parcels with less than the minimum five acre requirement, including a parcel with no public street frontage, affecting 17.43 acres of a 28.7 acre site in the C-R (Regional Commercial) Zone. 
