On February 20, 2020, the Del Mar Union School District ("District") posted and published a Notice of Intent ("NOI") to Adopt a Mitigated Negative Declaration ("MND") for the Del Mar Heights School Rebuild Project ("Project"). The NOI established a public review period from February 20, 2020 to March 23, 2020 ("Public Review Period"). The District's Governing Board of Trustees ("Board") was also scheduled to consider the MND at a March 25, 2020, Board meeting.

On March 18, 2020, the Board held an emergency meeting to discuss issues related to the COVID-19 virus crisis. At such meeting, the Board cancelled its March 25, 2020, meeting and scheduled a Special Board meeting to be held on April 14, 2020, at which time the Board will consider the MND.

**NOTICE IS HEREBY GIVEN** that the District is extending the Public Review Period so that the District will accept written comments on the proposed Project until <u>5:00 p.m. on March 30, 2020</u>. All written comments must be addressed to Chris Delehanty, Executive Director of Capital Programs and Technology, and timely emailed to cdelehanty@dmusd.org, or timely mailed to 11232 El Camino Real San Diego, CA 92130. Any email or mailing that is <u>received</u> after 5:00 pm on March 30, 2020, regardless of the date of mailing, will not be accepted or considered.
