Dear All,

In light of recent concerns around COVID-19 and the decision by the campus earlier today to limit gatherings of over fifty people and move to classes online, we are modifying the format of the LRDP EIR Scoping Sessions and extending the Scoping Period to provide alternative methods for public participation. We have outlined these changes below.

UC Santa Cruz LRDP EIR NOP Scoping Sessions on March 12, 2020 – LIVE VIDEO FORMAT ONLY

We will continue to conduct Scoping Sessions scheduled for March 12, 2020 but are modifying the hearing to a virtual format rather than an in-person event. The scoping sessions will be at the same time and date as originally planned:

- Campus Scoping Session | Thursday March 12, 2020 | 12pm – 2pm
- Community Scoping Session | Thursday March 12, 2020 | 6pm – 8pm

Both Scoping Sessions will be conducted via a live video feed; we will not be conducting an in-person session at Merrill Cultural Center and the Loudon Nelson Community Center. Please go to the following link to participate in each session: <https://video.ibm.com/channel/WfRRwzKR4We>

During each session, we will provide a brief presentation and will read the public comments we have received to date via the live video feed. The presentation will be posted online at <https://lrpd.ucsc.edu> before the event; the link to the live video feed will also be included online.

Please indicate which session, “Campus Session” or “Community Session” for which you would like your comments to be read aloud and provide your full name for the transcript. All comments received will be included in the record. Depending on the volume of comments received, and as is typical with all public hearings, we may limit each person’s comment to three minutes to make sure all comments are heard.

Additional Scoping Session

An additional Scoping Session will be added the first week of April. We anticipate this will also be a virtual session due to ongoing concerns about COVID-19. We will issue more detail in the coming week.
