**Brief Project Description:** The project is a rulemaking proceeding to create energy efficiency standards for replacement dedicated-purpose pool pump motors. This would apply to newly manufactured products sold in California. The project would also incorporate existing federal appliance efficiency regulation for dedicated-purpose pool pumps. The standards would not mandate new technologies or components.

**Determination:** Based on a review of the project as proposed, the Department of Fish and Wildlife has determined that for purposes of the assessment of CEQA filing fees (Fish & G. Code, § 711.4, subd. (c)) the project has no effect on fish, wildlife or their habitat and the project as described does not require payment of a CEQA filing fee.
