Description of Nature, Purpose, and Beneficiaries of Project:

In December 2016, Congress passed the Water Infrastructure Improvements for the Nation (WIN) Act, which authorized the conversion current water service contracts into repayment contracts and the prepayment of associated capital costs of construction, at a discounted rate. The project will benefit the City's ratepayers be eliminating the costs that would otherwise be incurred in renewing the City's Long-Term Water Service Contract, and by allowing the City to take advantage of a discount that the WIIN Act authorized for converting contractors, which will reduce the amount charged to the City for its share of the capital costs of constructing the Central Valley Project. The substantive terms of the Repayment Contract are the same as they were in the existing Water Service Contract because the WIIN Act directed Reclamation to convert the contracts without changing the substantive terms.


