City of Santa Cruz Water Department NOTICE OF AVAILABILITY OF AN ENVIRONMENTAL IMPACT REPORT

PROJECT TITLE: Laguna Creek Diversion Retrofit Project

The City of Santa Cruz as the Lead Agency has prepared a Draft Environmental Impact Report (EIR) for the Laguna Creek Diversion Retrofit Project (Proposed Project) pursuant to the California Environmental Quality Act.

PROJECT LOCATION: Laguna Creek, along Smith Grade in Bonny Doon in unincorporated Santa Cruz County

PROJECT DESCRIPTION: The Proposed Project would retrofit the existing Facility to provide for natural sediment transport past the diversion and to protect fish species and habitats. The retrofit would be comprised of the following primary components: new intake structure and screen; new intake structure appurtenances; new valve control vault; bank protection and armoring; new monitoring and control equipment; new access and safety provisions; and modifications to the existing intake and sediment control bypass valves. The Proposed Project would not increase the diversion rates, which would remain consistent with existing operations at the Facility.

ENVIRONMENTAL EFFECTS: The Draft EIR found that implementation of the Proposed Project may result in potentially significant environmental impacts to: biological resources, cultural resources and tribal cultural resources, geology and soils, and noise and vibration, which would be reduced to less than significant with mitigation measures identified in the EIR.

PUBLIC INFORMATION MEETINGS: Two public information meetings regarding the Proposed Project and Draft EIR will be held on **Wednesday**, **October 14**, **2020** at **2:00 PM** and **6:30 PM**.
