Notice of Exemption – Appendix E Pg. 2 (REVISED)

Reasons why project is exempt:

California Code of Regulations, title 14, section 15301 provides that projects which consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, and which involve negligible or no expansion of an existing or former use, are categorically exempt from the provisions of the California Environmental Quality Act. This project will install new manufacturing equipment at an existing, approximately 16,000-square-foot and 10,400-square-foot, two-building manufacturing facility in Campbell, California. The installed equipment will be scattered throughout the facility, with the largest new equipment footprint totaling approximately 200 square feet. The new equipment will be used to manufacture and validate electric vehicle DC fast chargers. No trenching or new concrete pad is necessary to install this new equipment. For these reasons, this project will not have a significant effect on the environment and is categorically exempt under CEQA Guidelines section 15301.

California Code of Regulations, title 14, section 15303 provides that projects which consist of construction and location of limited numbers of new, small facilities or structures; installation of small new equipment and facilities in small structures; and the conversion of existing small structures from one use to another where only minor modifications are made in the exterior of the structure, are categorically exempt from the provisions of the California Environmental Quality Act. The project will install various pieces of product validation testing equipment, each approximately the size of a refrigerator. The installed equipment will be scattered throughout the facility, with the largest new equipment footprint totaling approximately 200 square feet. No trenching or new concrete pad is necessary to install this new equipment. Therefore, the proposed project will not have a significant effect on the environment and falls under the categorical exemption listed in 14 C.C.R. § 15303.
