PROJECT DESCRIPTION

Project is located within the WUI communities of the Lake Madrone CA Planning area which includes one community at risk and will benefit neighboring communities. This project involves the clearing of brush, small trees (trees less than 10" in diameter) and dead woody debris (snags less than 10" in diameter), to reduce the existing fire hazard for that community. Fuel breaks shall be constructed adjacent to structures, and along public permanent and seasonal roads to reduce fuel loading along proposed escape routes. Fuels can be chipped, lopped and scattered, masticated, or hand piled for burning later in the season when moisture levels are sufficiently high enough to allow for safe disposal and minimal risk for fire escape. The project area is approximately 56.0 acres in size. The proposed work period for this project is scheduled for late Winter to early Spring 2020, with a goal of completing this work prior to the beginning of fire season. The burning of piles will take place in mid to late Fall 2020. Equipment used by the contractor(s) may include the following: chainsaws, pole saws, pruning shears, small rubber track masticator, and fire suppression tools. The project should be completed by late Fall 2020, but there may be some remnant pile burning in Spring 2021. This project is funded by the California Greenhouse Gas Reduction Fund (Grant Agreement Number 5GG17129). CAL FIRE Butte Ranger Unit shall be involved with this project by inspecting the project area after the completion of operations. The Ranger Unit personnel shall validate that the Fuels Treatment work has been satisfactorily completed and authorize the release of grant funds to pay contractors for projected area that has been treated.
