Project Title: Diversion of Water for Commercial Cannabis Irrigation (Lake or Streambed Alteration Agreement No. EPIMS-02639-R1)

Project Location (include county): The project is located at an unnamed tributary to Canyon Creek, which is then a tributary to the South Fork Trinity River, Trinity County, State of California; 40.688433°N, 123.527611°W; Assessor's Parcel Number 011-090-07-00.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-02639-R1, pursuant to Section 1602 of the Fish and Game Code to Richard Collins, representing Hole in the Earth, LLC.

The Project is limited to diversion of water from two separate locations. The first point of diversion (POD1) is a spring at the headwaters of Canyon Creek. The second point of diversion (POD2) is a second spring at the headwaters of Canyon Creek. The water is diverted using gravity, with a trickle flow diversion rate. The water is piped underground through a 1" pipe and fills a 2500-gallon tank near the springs. Using gravity, the water travels to the storage facilities. The maximum monthly diversion rate from each diversion is 29,500 gallons per month. There is a valve at each POD that can be closed to adjust flow to 1 gal /min. Each POD provides water necessary to irrigate the cannabis garden, irrigate up to an acre of food/landscaping and to provide 2 people with a domestic water supply year-round.

Water diverted for cannabis irrigation shall be diverted only during allowable times, and will be stored in a pond that is not hydrologically connected to other streams. Using a submersible Grundfos well pump powered by 3 solar panels, the water will be pumped during the forbearance season (April 1-October 31) to the places of use for cannabis cultivation.
