

## Notice of Intent to Adopt a Mitigated Negative Declaration 66-inch Trunk Sewer Rehabilitation Project: Kaiser Road to Soscol Water Recycling Facility (CIP 19701)

NOTICE IS HEREBY GIVEN that Napa Sanitation District (NapaSan) has prepared an Initial Study and Mitigated Negative Declaration (IS/MND) for the proposed 66-inch Trunk Sewer Rehabilitation Project (proposed project). The project would rehabilitate approximately 6,985 linear feet of 66-inch diameter trunk sewer pipeline using a trenchless rehabilitation lining system. To conduct the sewer rehabilitation/replacement work, installation of a temporary sewer bypass system would be necessary. The temporary bypass pipelines would be installed above-ground except at roadway and driveway crossings and through intersections where they would be temporarily shallow buried. There are several options for the placement of the bypass pipelines; the IS/MND evaluates the potential environmental impacts of all options, however the preferred option is Cured In Place Pipe (CIPP) method using Bypass Alternative 2 for crossing of the Bedford Slough as shown on the attached map. While the IS/MND prepared for the project identifies potentially adverse effects of the proposed project, mitigation measures are included that would ensure that all significant, adverse effects would be reduced to less than significant.

The project is generally bounded by Kaiser Road on the north, Napa Valley Corporate Drive on the east, Soscol Water Recycling Facility on the south, and the Napa River on the west. The proposed project is not on a list compiled pursuant to Government Code Section 65962.5.

**Public Review Period**: A 30-day period for review of the Draft IS/MND will begin on Wednesday, March 25, 2020 and end at 5:00 PM on Friday, April 24, 2020. Comments on the Draft IS/MND should focus on environmental issues.
