Sutter County anticipates leasing the excess parcel, APN: 59-010-071 located in Yuba City, CA off Highway 20, from the California Department of Transportation (Caltrans) for use as a temporary emergency shelter for the unsheltered per Governor Newsom's executive order N-23-20. The Governor's recent proclamation ordered a state of emergency, re. the COVID-19 virus, so we must expedite leases for quarantine/medical/sanitation projects. Sutter County is responsible for all clearances required. Once the parcel is leased, Sutter County will construct or place approximately 60 temporary tents, temporary bathrooms and hand washing stations, 4 temporary food stations, and 15 RVs on the property. 


