**Project Title:** Geazzer Timber Harvest Plan No. 4-19-00179/TUO (Streambed Alteration Agreement No. 1600-2019-0232-R4)

**Project Location (include county):** The Project locations occur between Little Beaver Creek and Griswold Creek, west of the community of Dorrington and north of the Calaveras Big Tree State, Tuolumne County, State of California, within Little Beaver and Grizzly Creeks, and unnamed tributaries of Little Beaver, Beaver, Grizzly, and Griswold Creeks; Sections 02, 11, 16, 20, 21, and 22 Township 5 North, Range 16 East, MDB&M; of USGS 7.5 minute quadrangles Boards Crossing.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number 1600-2019-0232-R4, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Sierra Pacific Industries. Project activities include installation of a vented fords, crossing maintenance, temporary crossings, waterhole construction and impoundments, and maintenance, operations, and other activities at water drafting sites, and perform erosion mitigation activities, related to the Geazzer Timber Harvest Plan in Tuolumne County, 4-19-00179/TUO.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on 4/3/2020 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW’s permitting jurisdiction as a Responsible Agency.
2. CDFW considered the Timber Harvest Plan prepared by the Lead Agency for this project pursuant to Z’berg-Nejedly Forest Practice Act and the California Forest Practice Rules, a CEQA-equivalent California Certified Regulatory Program.
3. Mitigation measures were made a condition of CDFW’s approval of the project.
4. A mitigation reporting or monitoring plan was adopted by CDFW for this project.
5. A statement of overriding considerations was not adopted by CDFW for this project.
6. Findings were made by CDFW pursuant to the Provisions of CEQA.
