The proposed project includes construction and operation of a RV fueling station and drive-through retail development on a 1.3-acre project site. The RV fueling station would be developed on a 0.53-acre parcel in the eastern portion of the project site, with three fueling positions beneath a 1,680-sf canopy. The drive-through retail would be developed on a 0.77-acre parcel in the western portion of the project site, with a 3,000-sf structure and drive-through queue along the western and southern side of the structure. Construction of the proposed project is anticipated to begin early summer 2020. The proposed project would be constructed in approximately three months.
