A zoning amendment to change the zoning of two parcels totaling approximately 41.5 acres from RR-20 (rural residential-minimum 20 acre parcels) to RA-20 (residential agriculture-minimum 20 acre parcels). The stated reason for the rezone is to allow for greater agricultural use on one parcel and to re-establish cannabis cultivation on the other parcel. This Negative Declaration examines the potential effects of non-cannabis activities, as the cannabis related activities are under the scope of the program EIR and addendum (SCH#2016042019) approved with the amendment to Calaveras County Code 17.95 on October 22, 2019.
