Caltrans proposes bridge rehabilitation at two locations on SR 78 in Palo Verde, and four locations on Interstate 8, all in Imperial County. Work scope, means and methods described are restricted per Environmental Commitments Record (ECR). Project work includes application of methacrylate deck treatment, paint steel and structure, replace bridge deck, place deck overlay on spot locations, patch spalls, replace joint and bearing as well as bridge rail upgrade. All work is within Caltrans' right-of-way.


