Description of Nature, Purpose, and Beneficiaries of Project: The proposed project would involve demolition of an existing groundwater monitoring well by Stantec Consulting (Applicant) on behalf of the Tesoro Refining and Marketing Company (Tenant) in the City of San Diego, California. Work to complete the proposed project would involve destruction of one (1) groundwater monitoring well, pressure grouting the well, and restoring to match surrounding surface with patched asphalt. Construction of the proposed project is anticipated to occur in the beginning of winter 2020 and would take approximately one day.

Due to its nature and limited scope, construction of the proposed project would generate a minor amount of vehicle trips and would require limited use of equipment.
