The Project proposes to construct a 2,217 foot long tieback soldier pile wall on State Route 1 from PM 26.67 to PM 27.09 located approximately eight feet to the west of the southbound lane. The soldier pile wall would consist of one row of tiebacks using structural fill behind the soldier pile wall to repair the highway slip outs. The maximum height of the soldier pile wall's laggings would be approximately twenty-five feet.
