Title: Lodi Lake Shoreline Restoration Project

Proponent: City of Lodi

Location: Sovereign land in the Mokelumne River, within Lodi Lake Park, adjacent to Assessor's Parcel Numbers 039-100-210, near Lodi, San Joaquin County.

Description: The project would place rock slope protection at two locations totaling 1,600 linear feet along the Mokelumne River to reduce riverbank erosion. Fill soil would be placed behind portions of the RSP for placement of turf grass and native aquatic vegetation. Existing concrete rubble at both locations would be removed.
