**Notice of Intent to Adopt a Mitigated Negative Declaration and Categorical Exclusion for
the State Route 39 and State Route 71 Seismic Retrofit and Bridge Rail Upgrade Project**

This notice is to inform you that the California Department of Transportation (Caltrans) is proposing a seismic retrofit and barrier replacement project on two bridge structures on separate routes within Los Angeles County; the San Gabriel River Bridge (Bridge Number 53-0113, Post Mile 17.81) on State Route (SR)-39 and the Ridgeway Street Undercrossing (Bridge Number 53-2052, Post Mile R0.92) on SR-71. Painting work and modification of the structure approach slabs are also proposed for the San Gabriel River Bridge. The existing bridge guardrails at the Ridgeway Street UC will be upgraded to current standards.

Caltrans is the lead agency for the California Environmental Quality Act (CEQA) and National Environmental Policy Act (NEPA). In conformity with the requirements of CEQA and NEPA, Caltrans has studied the environmental impacts of the proposed project and has prepared an Initial Study with a Proposed Mitigated Negative Declaration and a Categorical Exclusion.
