Project Title: Streambed Alteration Agreement No. 1600-2020-0116-R2 (Bear Pen Timber Harvesting Plan 2-20-00011-BUT, The CHY Company)

Project Location: The projects are located within the boundaries of a timber harvesting plan in Butte County, within CALWATER watersheds Oroleve Creek, Lewis Flat, and their connecting tributaries; Township 20N, Range 7E, Sections 27 and 33 of U.S. Geological Survey (USGS) Quad Map Clipper Mills; Mount Diablo Base and Meridian.

Project Description: The projects are limited to the replacement of an undersized corrugated metal pipe (CMP), the removal of a CMP and installation of a dipped crossing, and the installation of a vented ford crossing.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
