NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION FOR AR20-004/UP19-023 – STRATFORD SCHOOL CITY PARK CAMPUS

NOTICE IS HEREBY GIVEN that the City of San Bruno has prepared an Initial Study and intends to adopt a Mitigated Negative Declaration (MND) for the Stratford School – San Bruno City Park Campus project.

PROJECT SCOPE: Remodel of the former El Crystal Elementary School as a private preschool and kindergarten with a maximum enrollment of 348 students (288 Pre-K and 60 Kindergarten students); Demolition of existing secondary structures (totaling 2,909 square feet) on the southeast corner of the site and demolition of existing play areas; 3,280 square-foot addition to the existing primary structure to include three additional classrooms for an approximately 371 square-foot net increase over existing conditions; Construction of a new 83-space surface parking lot on the northwest portion of the site with a one-way entrance from Balboa Way and one-way exit to San Felipe Avenue and construction of a new 29-space staff parking area accessible from Anza Way.


