Rincon Consultants, Inc. (Rincon) was retained by Michael Baker International to perform a Phase I cultural resources assessment for the Bewley Street Townhomes Project (project) located at 1122 North Bewley Street, Santa Ana, Orange County, California. The purpose of this letter report is to document the results of the tasks performed by Rincon, specifically: a cultural resources records search, Sacred Lands File search, and a pedestrian field survey. This project is subject to the California Environmental Quality Act (CEQA), and the City of Santa Ana (City) is the lead agency for the project.

# Project Site

The project site is currently vacant and consists of a 0.87-acre lot located at 1122 North Bewley Street in Santa Ana, California. The property lies within the Anaheim Quadrangle, Township 5 South, Range 10 West, Section 10 (Figure 1, Attachment A). The project site is in-between West Washington Avenue and West 11<sup>th</sup> Street on a residential block of North Bewley Street. Other surrounding land uses include commercial development to the west. Interstate 5 is located approximately 3 miles northeast of the project site. The project would involve the development of a ten-unit townhome community.

# Cultural Resources Records Search

On January 7, 2020, Rincon Cultural Resource Specialist Alexandra Madsen, M.A., performed a search of the California Historical Resources Information System (CHRIS) at the South Central Coastal Information Center (SCCIC) located at California State University, Fullerton. The search was performed to identify all previously recorded cultural resources, as well as previously conducted cultural resources studies within the project site and a 0.5-mile radius surrounding it. The CHRIS search included a review of the National Register of Historic Places (NRHP), the California Register of Historical Resources (CRHR), the Office of



Historic Preservation Historic Properties Directory, the California Inventory of Historic Resources, and the Archaeological Determinations of Eligibility list.

The SCCIC records search identified 10 previously conducted cultural resources studies that have been performed within a 0.5-mile radius of the project site, none of which have been completed within the current project site. Additionally, there are 19 previously recorded cultural resources within a 0.5-mile radius of the project site, all of which are historic buildings. No resources were noted within the project site and no prehistoric archaeological sites have been recorded within the search radius. For a full list of resources and studies conducted in the search area, see Attachment B.

Rincon completed a review of historical aerials available for the project site. Aerial images for the project site are available from 1952, 1953, 1963, 1968, 1972, 1995, 2003-2005, 2009, 2010, 2012, 2014, and 2016 (UCSB 1952 and 1968, Historic Aerials n.d.). According to the aerial imagery, the western half of the project site was developed at least as early as 1952 with a 1-story single family residence. The property remained in place until its demolition in 2019. The project site has remained vacant since that time.

# Sacred Lands File Search

On December 27, 2019, Rincon contacted the Native American Heritage Commission (NAHC) and requested a search of the Sacred Lands File (SLF). The NAHC emailed a response on January 13, 2020, stating that the SLF search was returned with negative results (Attachment C). Rincon sent letters on January 21, 2020, to the NAHC-listed contacts included with the SLF results. To date, no responses from these contacts have been received.

# Pedestrian Field Survey








Figure 2. Overview of the Project Site from Western edge, view East

Ms. Madsen conducted a pedestrian field survey of the project site on January 17, 2020 (Figures 2 and 3, Attachment A). Areas of exposed ground were inspected for prehistoric artifacts (e.g., flaked stone tools, tool-making debris, stone milling tools, ceramics, fire-affected rock), ecofacts (marine shell and bone), soil discoloration that might indicate the presence of a cultural midden, soil depressions, and features indicative of the former presence of structures or buildings (e.g., standing exterior walls, postholes, foundations) or historic debris (e.g., metal, glass, ceramics).

Ground disturbances such as burrows and drainages were also visually inspected. Results of the field survey identified no evidence of archaeological remains or historic built-environment resources within the project site. Ground visibility throughout the project site was poor (approximately 20 percent) due to vegetation including grass and weeds (Figure 2). Ornamental trees line the eastern boundary of the parcel and would have flanked the recently-demolished residence. The project site is highly disturbed due to past development and the subsequent demolition of the structure. Modern disturbances on the project site include stockpiles of soil and rock debris. Modern refuse is stacked along the southern boundary (Figure 3). No prehistoric cultural resources were identified within the project site.



# Findings and Recommendations

Based on the results of the cultural resources records search and intensive pedestrian field survey, no cultural resources were identified within the project site. Due to past disturbance within the project site and a lack of archaeological resources in the records search radius, the project site is considered to have low archaeological sensitivity. Based on these results, Rincon recommends a finding of *less than significant impact to historical resources and archaeological resources* for the purposes of CEQA and does not recommend any additional cultural resources work at this time. The following mitigation measure is recommended in the case of unanticipated discoveries during ground-disturbing activities.

# Unanticipated Discovery of Archaeological Resources

If archaeological resources are encountered during ground-disturbing activities, work in the immediate area should be halted and an archaeologist meeting the Secretary of the Interior's Professional Qualification Standards for archaeology (National Park Service 1983) should be contacted immediately to evaluate the find. If necessary, the evaluation may require preparation of a treatment plan and archaeological testing for CRHR eligibility. If the discovery proves to be eligible for the CRHR and cannot be avoided by the project, additional work, such as data recovery excavation, may be warranted to mitigate any significant impacts to historical resources.

# Unanticipated Discovery of Human Remains

The discovery of human remains is always a possibility during ground-disturbing activities. If human remains are found, the State of California Health and Safety Code Section 7050.5 states that no further disturbance shall occur until the County Coroner has made a determination of origin and disposition pursuant to Public Resources Code Section 5097.98. In the event of an unanticipated discovery of human remains, the County Coroner must be notified immediately. If the human remains are determined to be prehistoric, the Coroner will notify the Native American Heritage Commission, which will determine and notify a most likely descendant (MLD). The MLD shall complete the inspection of the site and provide recommendations for treatment to the landowner within 48 hours of being granted access.



Dear Mr. Guevara:

Attached is a consultation list of tribes with traditional lands or cultural places located within the boundaries of the above referenced counties or projects.

Government Codes §65352.3 and §65352.4 require local governments to consult with California Native American tribes identified by the Native American Heritage Commission (NAHC) for the purpose of avoiding, protecting, and/or mitigating impacts to cultural places when creating or amending General Plans, Specific Plans and Community Plans.

Public Resources Codes §21080.3.1 and §21080.3.2 requires public agencies to consult with California Native American tribes identified by the Native American Heritage Commission (NAHC) for the purpose of avoiding, protecting, and/or mitigating impacts to tribal cultural resources as defined, for California Environmental Quality Act (CEQA) projects.

The law does not preclude local governments and agencies from initiating consultation with the tribes that are culturally and traditionally affiliated within your jurisdiction. The NAHC believes that this is the best practice to ensure that tribes are consulted commensurate with the intent of the law.

Best practice for the AB52 process and in accordance with Public Resources Code §21080.3.1(d), is to do the following:

Within 14 days of determining that an application for a project is complete or a decision by a public agency to undertake a project, the lead agency shall provide formal notification to the designated contact of, or a tribal representative of, traditionally and culturally affiliated California Native American tribes that have requested notice, which shall be accomplished by means of at least one written notification that includes a brief description of the proposed project and its location, the lead agency contact information, and a notification that the California Native American tribe has 30 days to request consultation pursuant to this section.

The NAHC also recommends, but does not require that lead agencies include in their notification letters, information regarding any cultural resources assessment that has been completed on the area of potential affect (APE), such as:

- 1. The results of any record search that may have been conducted at an Information Center of the California Historical Resources Information System (CHRIS), including, but not limited to:
  - A listing of any and all known cultural resources have already been recorded on or adjacent to the APE, such as known archaeological sites;
  - Copies of any and all cultural resource records and study reports that may have been provided by the Information Center as part of the records search response;
  - Whether the records search indicates a low, moderate or high probability that unrecorded cultural resources are located in the APE; and
  - If a survey is recommended by the Information Center to determine whether previously unrecorded cultural resources are present.
- 2. The results of any archaeological inventory survey that was conducted, including:
  - Any report that may contain site forms, site significance, and suggested mitigation measures.

All information regarding site locations, Native American human remains, and associated funerary objects should be in a separate confidential addendum, and not be made available for public disclosure in accordance with Government Code Section 6254.10.

- 3. The result of the Sacred Lands File (SFL) check conducted through the Native American Heritage Commission was <u>negative</u>.
- 4. Any ethnographic studies conducted for any area including all or part of the potential APE; and
- 5. Any geotechnical reports regarding all or part of the potential APE.

Lead agencies should be aware that records maintained by the NAHC and CHRIS is not exhaustive, and a negative response to these searches does not preclude the existence of a tribal cultural resource. A tribe may be the only source of information regarding the existence of a tribal cultural resource.

This information will aid tribes in determining whether to request formal consultation. In the event, that they do, having the information beforehand well help to facilitate the consultation process.

If you receive notification of change of addresses and phone numbers from tribes, please notify the NAHC. With your assistance we can assure that our consultation list remains current.
