Description of Nature, Purpose and Beneficiaries of Project:

HDR Engineering and Syblon-Reid will perform destructive examination of Grizzly Dam spillway. All work will be confined to the interior of spillway consisting of concrete coring in numerous locations through the invert of the spillway. Concrete pieces will be removed to expose and repair damaged rebar. Scaffolding will be temporarily installed within the spillway to facilitate access. The contractor shall follow BMP's to contain drilling fluids and dispose of waste water at an approved facility offsite. All equipment staging will be on improved areas near the crest and toe of the dam. All work will be within DWR right-of-way.
