The center of the project is near 40.006055° latitude, -121.249060° longitude (WGS 84 datum).

Description of Nature, Purpose or Beneficiaries of Project: The County proposes to rehabilitate and extend the life of the bridge by removing old paint via blasting, cleaning, and repainting all steel elements. In addition, the proposed project will include minor preventative maintenance repairs to steel elements per Caltrans Bridge Inspection Reports.
