 The proposed project will be located southeast of the intersection of Balboa Boulevard and San Fernando Road in Granada Hills. The site is located within the north end of LADWP's Van Norman Complex.

DESCRIPTION OF NATURE, PURPOSE, AND BENEFICIARIES OF PROJECT:
 LADWP will install a secondary LADWP-owned flow meter along the existing MWD LA-35 service connection to ensure the accuracy in meter reading and billing of supply data on its largest and most commonly used connection with Metropolitan Water District. The MWD LA-35 New Flow Meter Project will improve the accuracy and reliability of water supply volume, which has the largest impact on the accuracy of annual water loss audit.
