The project site is located on the west side of South Lassen Avenue (State Route 269) approximately 4,480 feet south of its nearest intersection with West Mount Whitney Avenue and is approximately 12.9 miles southeast of the nearest city limits of the City of San Joaquin (APN 050-130-04S) (21929 S. Lassen Avenue, Five Points, CA).

AE-20 (Exclusive Agricultural, 20-acre minimum parcel size)

8. Description of project: (Describe the whole action involved, including, but not limited to, later phases of the project, and any secondary, support, or off-site features necessary for its implementation. Attach additional sheets if necessary.)

Amend CUP 2085 to allow expansion of an existing fertilizer operation on a 5.02-acre parcel in the AE-20 (Exclusive Agricultural, 20-acre minimum parcel) Zone District. The project specifically requests to allow construction of a new 4,800 square-foot containment area that will house six tanks. The tanks are proposed to have a capacity between 15,963 gallons and 6,500 gallons.

9. Surrounding land uses and setting: Briefly describe the project's surroundings:

The subject parcel is located in an area utilized mostly for agricultural. An agricultural supportive operation is located directly southeast of the project site. It should also be noted that the project site is located approximately 1,900 feet south of a cluster of commercial and residential uses at the intersection of West Mount Whitney Avenue and South Lassen Avenue.

Participating California Native American Tribes were notified of the subject application and given the opportunity to enter into consultation with the County pursuant to AB 52 regulation. No participating California Native American Tribe entered into consultation with the County of Fresno. A Mitigation Measure has been implemented in the event that cultural resources are identified during ground disturbance related to the project.

NOTE: Conducting consultation early in the CEQA process allows tribal governments, lead agencies, and project proponents to discuss the level of environmental review, identify and address potential adverse impacts to tribal cultural resources, and reduce the potential for delay and conflict in the environmental review process. (See Public Resources Code section 21080.3.2.) Information may also be available from the California Native American Heritage Commission's Sacred Lands File per Public Resources Code section 5097.96 and the California Historical Resources Information System administered by the California Office of Historic Preservation.
