We have a Policy 306, Response Time Standards which includes:

- a. One minute or less for dispatch processing time.
- b. One minute or less for turnout time for Emergency Medical Services (EMS) incidents.
- c. One minute 20 seconds or less for turnout time for non-EMS incidents.
- d. Four minutes or less for the arrival of the first engine company at a fire suppression incident.
- e. Eight minutes or less for the arrival of a full first-alarm assignment at a fire suppression incident.
- f. Four minutes or less for the arrival of a unit with first responder or higher level capability at an EMS incident.
- g. Eight minutes or less for the arrival of an advanced life support (ALS) unit at an EMS incident when this service is provided by the Department.

- c. Please provide data on current response times/service ratios, if available. We believe we are striving to meet the performance objective. Our average total response time in 2019 was 5 minutes.


Project Location: The proposed Project site is bound by Palm Avenue on the north, PCH on the east, Holly Avenue on the south, and Indiana Street on the west. Mariposa Avenue bisects the portions of the Project site. Access to the Project site is currently provided by PCH on the east and Indiana Street to the west. See the attached Figure 2-1, Project Location, for the limits of the Project site boundaries.

Project Overview: The Project would redevelop the existing surface parking lots of the Fairfield Inn & Suites and Aloft Hotel properties, as well as the old Hacienda Restaurant, through the adoption of a Specific Plan that allows for the development of 263 new housing units and approximately 11,100 square feet of commercial/retail uses, while maintaining the existing hotels and associated 596 rooms. The Project is projected to generate a resident population of approximately 627 individuals (i.e. 263 residential units at 2.385 persons/unit).

- Provide a list of all Police Department stations that may serve the Project site, and a summary of existing staffing and community services at each station. El Segundo currently has one police station located at 348 Main Street staffed by 56 sworn officers (we are budgeted for 62 sworn) and 22 full time civilian staff. We also budget for 15 cadets (part-time spots).
- 2. Are there established performance standards/objectives for maintaining acceptable service ratios (officer-to-resident ratio) or response times?
 - a. If so, please provide established performance standards/objectives. ESPD staffs at least 1 sergeant plus 4 patrol officers during dayshift but will go down to a minimum number of 3 officers depending on staffing situations. These numbers slightly increase during evening shifts. Additionally, we deploy at least 1 motorcycle officer during dayshift to address traffic concerns.
 - b. Are these established performance standards/objectives being achieved? Please provide data on current response times/service ratios, if available. Our current established performance standards are being achieved. Our current response times for Priority 1 calls are between 2.16 minutes and 4.25 minutes. Priority 2 calls are between 5.15 minutes and 10.08 minutes. (Chart below to explain)




