PROJECT LOCATION: The Project is located near the south shore of Clear Lake, in Lake County, about 3.5 miles northeast of the town of Kelseyville. The proposed tank site is located in the "Clear Lake Riviera" area, west of Soda Bay Road, at the north end of Osceola Avenue.

PROJECT DESCRIPTION: The State Water Resources Control Board (State Water Board) is the Lead Agency for the Project. The State Water Board's Drinking Water State Revolving Fund (SRF) Program is financing the Project. The Project includes replacement of the existing 35,000-gallon redwood tank and three 10,000-gallon temporary plastic tanks with a single 122,000-gallon welded steel tank. The new storage tank would be approximately 32 feet in diameter and 26.5 feet tall and would be welded in place on a perimeter-reinforced concrete-ring foundation supported by subgrade soil. Two mature pine trees would be removed for Project construction. All construction laydown and storage would occur on the site. The new tank would be accessed by a new paved driveway, and a paved apron would surround the new tank.

PUBLIC AGENCY APPROVING PROJECT AND CARRYING OUT PROJECT: The State Water Board has approved SRF financing for the Project described above on June 7, 2021. The Clearwater Mutual Water Company will be carrying out the Project. The State Water Board has made the following California Environmental Quality Act (CEQA) determinations regarding the Project:

- 1. The Project will not have a significant effect on the environment.
- 2. A Mitigated Negative Declaration was prepared and adopted for the Project pursuant to the provisions of CEQA.
- 3. Mitigation measures were made a condition of approval of the Project.
- 4. A mitigation monitoring and reporting plan/program was adopted for the Project.
