Project Description (Proposed actions, location, and/or consequences).

A gasoline fuel station, convenience market, car wash, and recreational vehicle storage facility on a developed parcel. The gas station/convenience market/car wash operations would be located on the western portion of the site within a total area of approximately 1.78 acres. The remaining 1.16 acres would be used for recreational vehicle storage. The operation would employ 2 full-time employees. The gas station/convenience market/car wash would be open to the public and would contain a retail component with operational hours of 5:00 AM to 11:00 PM daily.

Air Quality: Implement dust control measures and BAAQMD BMPs

Geology and Soils: Geotech/grading report review and approval; site inspection after first heavy rain event; implement an Erosion and Sediment Control Plan as approved by Permit Sonoma; paleontological resources education program;

Hazards and Hazardous Materials: Implement approved spill, prevention, control, and countermeasure (SPCC) plan; storage requirements for potentially hazardous materials; asbestos and lead-based paint building survey

Hydrology and Water Quality: Participate in water discharge program; low impact design requirements; grading and drainage plan and BMPs; groundwater monitoring; drainage report review and approval; floodplain construction complian Noise: Regulate construction activities (hours, operations, protocol)

Transportation: Restripe SR-12; install new signage to queuing and to prevent collisions; new bicycle, transit, and public transit improvements; implement Traffic Control Plan; driveway entrance regulations;
