AMENDMENT NO. 2 TO THE AMENDED AND RESTATED JOINT EXERCISE OF POWERS AGREEMENT

This project is the second amendment to the Amended and Restated Joint Exercise of Powers Agreement between DWR and the Delta Conveyance Design and Construction Joint Powers Authority (Authority) to provide for Authority support of appropriate feasibility and planning studies for possible future actions that DWR and the Authority have not approved, adopted, or funded.

The purpose of the amendment is to amend and revise the following contents of the Agreement: amending the Performance and Procurement of Services section to indicate that the DCA shall be fully responsible for all contracted work, to include quality and timeliness; amending the Reimbursement Clause consistent with the rates set forth in the Authority's travel and other reimbursement policies; revising the budget of the Initial DWR Contribution; amending all references to "Deputy Director" to Executive Director"; and amending Section 8 to read as "Property Acquisition".
