Notice of Availability of a Draft Environmental Impact Report (EIR)/Environmental Impact Statement (EIS) with Draft Section 4(f) Evaluation and Notice of Public Hearings for the SR 82 (El Camino Real) Roadway Renewal Project



WHAT'S BEING PLANNED: The California Department of Transportation (Caltrans) is proposing the El Camino Real Roadway Renewal Project. The project proposes to rehabilitate the roadway and sidewalks, improve visibility, improve drainage efficiency to reduce localized flooding, and enhance pedestrian infrastructure and bring it into compliance with Title II of the Americans with Disabilities Act (ADA) on State Route (SR) 82 (El Camino Real) from East Santa Inez Avenue to Millbrae Avenue in the cities of San Mateo, Burlingame, Millbrae, and the town of Hillsborough in San Mateo County.

The environmental consequences of the project are summarized in the Draft EIR/EIS. The project would result in potentially significant environmental impacts in relation to aesthetics, cultural resources, and noise. All of these impacts could be mitigated to a less-than-significant level except for the significant effect on aesthetics and cultural resources. Among Caltrans' findings, the agency considers that the proposed project would have an adverse effect on historic properties eligible for the National Register of Historic Places defined under Section 106 of the National Historic Preservation Act. Caltrans has prepared an Individual Section 4(f) Evaluation that also considers these properties as Section 4(f) resources under the Department of Transportation Act (1966). There are no active hazardous waste sites within the state right-of-way identified pursuant to Government Code Section 65962.5 (Cortese List).
