Project Description:	To allow for the recordation and development of a 71-lot single-family residential subdivision (Tentative Tract Map 20088) with 7,200 sq. ft. minimum size lots, on an approximately 20-acre building site that is vacant, undeveloped, and previously disturbed with an approximate density of 3.5 units per acre.	
Project Location:	North of and abutting Seneca Road, South of and abutting Villa Street, East of Highway 395 and West of Mesa Linda Avenue; APN: 3135-361-05 & 06; Within the City of Victorville, County of San Bernardino, State of California, San Bernardino Meridian, Section 15, Township 5N, Range 5W.
