Subject: Notice of Intent to Adopt a Mitigated Negative Declaration

Project Title: Krameria Avenue Tentative Tract Map (TTM) No. 37725 (PEN19-0188)

Location: The project site is located at the southwest corner of Krameria Avenue and

Perris Boulevard in the City of Moreno Valley, Riverside County, California

(APNs: 316-110-005, 006, 022, 023, and 024)

Applicant/Owner: PI Properties No. 67 LLC

PROJECT DESCRIPTION: The project consists of Tentative Parcel Map 37725 to subdivide approximately 20.18 acres into sixty-six (66) single-family residential lots ranging in size from 7,212 square feet to 15,951 square feet with associated improvements including streets, sidewalks and one (1) lettered lot for water quality requirements.

ENVIRONMENTAL DETERMINATION: The City of Moreno Valley has reviewed the above project and has prepared an Initial Study in accordance with California Environmental Quality Act (CEQA) Guidelines Section 15070. The Mitigated Negative Declaration represents the City's independent judgment and analysis. The proposed project will not have a significant effect on the environment with the implementation of mitigation measures.

PUBLIC CIRCULATION: The Draft IS/MND is being circulated for review and comment by interested agencies, organizations, and persons for 30 days in accordance with Section 21091 of the State CEQA Guidelines. A 30-day public review period to solicit comments on the Draft IS/MND starts June 5, 2020 and ends July 6, 2020.
