Project Location

The project site is located in the Fortuna area, on the south side of Rohnerville Road, at the intersection of Rohnerville Road and Kemp Lane, on the properties known as 111 Kemp Lane and 117 Kemp Lane.

General Plan Designation

Residential Estates (RE); Humboldt County General Plan. Density: one unit per 2.5 – 5 acres.

Zoning

Agriculture General (AG).

Project Description

A Minor Subdivision to divide an approximately eight-acre parcel into three parcels of 2.78 acres, 2.10 acres and 3.20 acres. The parcel is currently developed with an existing residence, a small cabin and several detached shops/sheds. Proposed Parcel 1 will be vacant and suitable for residential development, while proposed Parcels 2 and 3 will contain the existing residence and cabin, respectively. Proposed Parcel 2 will be served with water provided by the City of Fortuna and proposed Parcels 1 and 3 will be served by an on-site well located on proposed Parcel 1. All parcels will be served with on-site wastewater treatment systems. Pursuant to Section 325-9 of the Subdivision Regulations, an exception request was submitted to reduce the required right of way width and road width of the existing access road. A Calfire exception request was also submitted and approved to allow a reduced road width. Additionally, pursuant to Section 325-11 of the Subdivision Regulation, a Special Permit is required for Lot Size Modification to allow proposed Parcel 2 to be created as 2.10 acres.

Baseline Conditions: Surrounding Land Uses and Setting

The project site is located on the south side of Rohnerville Road, approximately 2,000 feet southeast of the City of Fortuna. The parcel is surrounded by similarly sized rural residential/agricultural parcels.

Other Public Agencies Whose Approval Is or May Be Required (permits, financing approval, or participation agreement): Humboldt County Public Works Department, Division of Environmental Health, Building Division, Calfire.

Discussion:

(a-d) Less Than Significant Impact: The project site is not within an area mapped or designated with scenic vistas or resources nor is it in the Coastal Zone where specified areas of scenic values are mapped and certified by the state. The proposed subdivision is consistent with the current zoning and general plan designation, and is consistent with the planned build-out of the area. The parcels will be served by Rohnerville Road, a County Road, as well as a private road accessed via Rohnerville Road. The Department finds no evidence that the division of the parcel within an area characterized as rural residential will have a substantial adverse aesthetic impact. No additional development is proposed, therefore, there is no indication that the project will significantly increase light or glare or effect nighttime views in the vicinity.

(a-e) Less Than Significant: Neither the subject property nor adjacent lands are within a Williamson Act contract. While the site contains mapped prime soils, the subdivision will not prohibit the continued use of these lands. Furthermore, agricultural protection policies identified in the General Plan involve lands planned Agriculture Exclusive and not Residential Estates, as the subject parcel is planned. The site does not contain unique farmland, however, there is some small-scale grazing occurring on the lands. The subdivision will not inhibit the grazing activities and other agriculture activities may be possible. The neighborhood is characterized by rural residential development with on-site water and wastewater services. The proposed subdivision is consistent with the existing zoning and general plan designation. One-family residential is a primary and compatible use within the RE designation and is principally permitted in the AG zoning district. General agriculture is an allowed use, and the subdivision will not limit future agricultural opportunities on the parcels. The Department finds no evidence that the project will result in a significant adverse impact on agricultural resources.

Discussion:

(a-e) Less than Significant: The project site is located within the North Coast Air Basin and the jurisdiction of the North Coast Unified Air Quality Management District (NCUAQMD). The North Coast Air Basin generally enjoys good air quality, but has been designated non-attainment (does not meet federal minimum ambient air quality standards) for particulate matter less than ten microns in size (PM₁₀). To address this, the NCUAQMD adopted a Particulate Matter Attainment Plan in 1995. This plan presents available information about the nature and causes of PM₁₀ standard exceedance, and identifies cost-effective control measures to reduce PM₁₀ emissions, to levels necessary to meet California Ambient Air Quality Standards. These include transportation measures (e.g., public transit, ridesharing, vehicle buy-back programs, traffic flow improvements, bicycle incentives, etc.), land use measures (infill development, concentration of higher density adjacent to highways, etc.), and combustion measures (open burning limitations, hearth/wood burning stove limitations; NCUAQMD 1995).

The proposed subdivision divides a parcel into three parcels all suitable for residential development. The project would not: (1) obstruct implementation of the applicable air quality plan; (2) violate air quality standards; (3) contribute substantially to an existing or projected air quality violation; (4) expose sensitive receptors to substantial pollutant concentrations; or (5) create objectionable odors.

(a) Less Than Significant with Mitigation Incorporated:

The access road serving the subdivision will require widening. There are trees that may need to be removed alongside the road. Therefore, in order to comply with the Migratory Bird Treaty Act and Fish and Game Code, tree removal and brush clearing must be conducted outside of the nesting season. This measure is included in Mitigation Measure No. 1.

(b-f) Less Than Significant: The project site is not within an adopted or proposed habitat conservation plan. The area is developed with a residence, cabin and accessory structures. According to the California Natural Diversity Database, a portion of the site has the potential to provide habitat to the foothill yellow-legged frog (Rana boylii), however, the entire parcel has historically been utilized for grazing, impacting potential habitat. The project was referred to the California Department of Fish and Wildlife, however, they did not respond with any concerns. The Department finds no evidence that the project will result in a significant adverse impact on any habitat conservation plan.

Mitigation Measure No.1. The Development Plan shall include the following language: "Tree removal and vegetation clearing associated with the Project should be conducted outside of the bird breeding season (the nesting season is generally considered to be March 1 – August 15) in order to avoid 'take' as defined and prohibited by Fish and Game Code (FGC) §3503, 3503.5, 3513, and by the Federal Migratory Bird Treaty Act (16 U.S. Code 703 et seq.). If work must be conducted during the bird nesting season, a qualified ornithologist (someone who is able to identify Northern California birds, and who has experience in nest-searching for passerines and raptors) should thoroughly survey the area no more than seven days prior to tree/vegetation removal to determine whether active nests (nests containing eggs or nestlings) are present. If active nests are found, appropriate buffers should be developed in consultation with CDFW to avoid take."

Discussion:

(a) No Impact: No historical resources have been documented on site. The site is currently vacant, therefore, the project will have no impact on historical resources defined in California Environmental Quality Act (CEQA) §15064.5.

(b,d) Less Than Significant with Mitigation Incorporated: Pursuant to AB52, the project was referred to the Northwest Information Center (NWIC), the Bear River Band of the Rohnerville Rancheria and the Wiyot Tribe. The NWIC recommended a cultural resource study and consultation with the local Tribes. Upon further consultation with the Bear River Band of the Rohnerville Rancheria and the Wiyot Tribe, it was recommended that the project be approved with no further study provided a note regarding inadvertent discovery is included in the project. If archaeological resources are encountered during construction activities, the contractor will execute Mitigation Measure No. 2. by halting construction and coordinating with a professional archaeologist, who meets the Secretary of the Interior's Standards and Guidelines and appropriate tribes so resources can be evaluated so that there is not a substantial adverse change in the significance of an archaeological resource. The project is not expected to disturb any human remains, including those interred outside of formal cemeteries. However, implementation of Mitigation Measure No. 2 has been included in the event that human remains are accidentally discovered during construction.

Mitigation Measure No. 2. The following note shall be place on the Development Plan and carried out through project implementation: "If suspected archaeological resources are encountered during the project: 1. Stop work within 100 feet of the find; 2. Call the Calfire project representative, a professional archaeologist and representatives from the Blue Lake Rancheria, Bear River Band of the Rohnerville Rancheria and the Wiyot Tribe; 3. The professional historic resource consultant, Tribes and Calfire

officials will coordinate and provide an assessment of the find and determine the significance and recommend next steps.

"If human remains are encountered: 1. All work shall stop and per CA Health and Safety Code Section 7050.5: 2. Call the Humboldt County Coroner at (707) 445-7242; 3. The Coroner will determine if the remains are of prehistoric/historic Native American origin. If the remains are Native American Heritage Commission within 24 hours. 5. The NAHC is responsible under CA PRC 5097.98. (a) for identifying the most likely descendent (MLD) immediately and providing contact information. The MLD may, with the permission of the owner of the land, or his or her authorized representative, inspect the site of the discovery of the Native American human remains and may recommend to the owner means for treatment or disposition, with appropriate dignity, of the human remains and any associated grave goods. The descendants shall complete their inspection and make recommendations or preferences for treatment within 48 hours of being granted access to the site."

The applicant is ultimately responsible for ensuring compliance with this condition."

Discussion:

(a-b) Less Than Significant Impact: The project will result in short-term energy consumption during the construction phase, with long-term energy consumption associated with the ongoing occupancy of the homes. The construction phase is not anticipated to utilize excessive energy and the one new home will be constructed compliant with the energy requirements of Title 24 of the Building Code. Therefore, a less than significant impact will occur.

- (a) Less Than Significant impact: There are no known earthquake faults located within the site.
- (i-iv) Less Than Significant impact: The proposed project divides one parcel into three. The subject property is located within an area of low geologic instability (Humboldt County General Plan Geology, General Plan Map) and is not within the Alquist-Priolo Fault Hazard Zone. The project will not expose people or structures to potential substantial adverse effects from rupture of a known earthquake fault, strong seismic ground shaking, or seismic-related ground failure, including liquefaction. The project is not within an area subject to landslides; therefore the project will not expose people or structures to risk of lost, injury, or death involving landslides.
- **(b) Less Than Significant impact**: Any future development or road improvements will utilize appropriate Best Management Practices (BMPs) which will prevent soil erosion and loss of topsoil.
- (c) Less Than Significant impact: The project is not located on geologic units or soils that are unstable or that will become unstable as a result of the project. The project will not result in the creation of new unstable areas either on or off site due to physical changes in a hill slope affecting mass balance or material strength.

(a-b) Less Than Significant Impact: In 2002 the California legislature declared that global climate change was a matter of increasing concern for the state's public health and environment, and enacted law requiring the California Air Resources Board (CARB) to control GHG emissions from motor vehicles (Health & Safety Code §32018.5 et seq.). In 2006, the California Global Warming Solutions Act (Assembly Bill 32) definitively established the state's climate change policy and set GHG reduction targets (health & Safety Code §38500 et sec.), including setting a target of reducing GHG emissions to 1990 levels by 2020. AB 32 requires local governments to take an active role in addressing climate change and reducing greenhouse gas (GHG) emissions. While methodologies to inventory and quantify local GHG emissions are still being developed, recommendations to reduce residential GHG emissions include promoting energy efficiency in new development.

The proposed project involves the division of a parcel into three and the ultimate development of one new residence on proposed Parcel 1. The eventual residential construction on the vacant lot would contribute temporary, short-term increases in air pollution from equipment usage. Because of the temporary nature of the greenhouse gas contributions, coupled with the modest quantity of emission, the proposed project would not have a significant impact on the environment, nor conflict with applicable plan, policy, or regulation for the purposes of reducing greenhouse gas emissions. Future residential use would emit limited greenhouse gases.

(a-g) Less Than Significant impact: The project site is not included on a list of hazardous material sites, nor does the proposed subdivision involve routine transport, use or disposal of hazardous materials. The project site is approximately one-half mile east of Rohnerville Airport and within the airport compatibility zone D (Other Airport Environs). Zone D does not have any density or land use restrictions but does require a Deed notice. There are no private airstrips within the vicinity of the project site. The site will not result in unanticipated risk to the occupants of the site. The Department finds no evidence that the project will create, or expose people or property to, hazardous materials, or impair implementation of, or physically interfere with, an adopted emergency response plan. The site is within the Fortuna Fire Protection District as well as the State Responsibility Area (SRA) for fire protection. Future development of the site will require compliance with the Uniform Fire Code and UBC. According to the Fire Hazard Severity map, the parcel is located in a moderate fire hazard severity area. Fortuna Fire Protection District and Calfire recommended road improvements consistent with an approved exception request. For these reasons, the Planning Division expects that the subdivision will not result in significant impacts in terms of hazardous materials.

(a-e) Less than significant Impact: The proposed subdivision is consistent with the planned density of the area, in terms of both the County's Housing Element and the recently adopted Humboldt County General Plan 2017. The project site is an area that relies upon on-site water and wastewater systems. The applicant has submitted dry-weather water testing results from the existing well located on proposed Parcel 1. The Division of Environmental Health (DEH) reviewed this information and found that each parcel will have adequate water availability. DEH has not identified any concerns with regard to the project interfering with groundwater recharge. The Department finds no evidence indicating that the subdivision will violate any water quality or waste discharge standards, or otherwise substantially degrade water quality. According to the Flood Insurance Rate Map, the project site is located outside the 100- and 500-year floodplains. The project site is not within a mapped dam or levee inundation area. The site sits at about 400 feet in elevation and is outside the areas subject to tsunami run-up.

A drainage report was not required due to the large parcel sizes and the ability to accommodate stormwater runoff on-site. The project was reviewed by Public Works and they recommended as a condition of approval that the applicant submit a complete hydraulic report and drainage plan for their approval. No streams, creeks or other waterways will be altered as a result of this subdivision. The Department finds no evidence that the proposed project will result in significant hydrologic or water quality impacts.

One-family residential is a primary and compatible use within the RE designation and is principally permitted in the AG zoning district. The neighborhood is characterized as rural residential with similar sized parcels involved in small-scale agriculture operations. The division of the existing parcel is consistent with the zoning and land use density (one unit per 2.5 – 5 acres). (a-e) Less Than Significant: Emergency response in the project area is the responsibility of the Fortuna Fire Protection District, Calfire and the Humboldt County Sheriff's Office. The proposed project will divide a parcel into three, with the potential development of one additional residence on proposed Parcel 1. The parcel is accessed by Rohnerville Road, a County maintained road. The parcels will take access via Kemp Lane, a private road that will serve only the three proposed parcels. The road will be improved consistent with an approved exception request for a reduced road width. Discussion:

(a-d) Less Than Significant Impact: The parcel is accessed by Rohnerville Road, a County maintained road. The parcels will take access via Kemp Lane, a private road that will serve only the three proposed parcels. The Land Use Division of Public Works has recommended standard conditions of approval including minor road improvements to the existing roads.

CEQA Guidelines Section 15064.3(b) requires land use projects to analyze traffic impacts based on vehicle miles traveled (VMT). While no thresholds of significance have been adopted by the County, the Office of Planning and Research (OPR) uses household VMT per capita as a recommended threshold with a threshold of 15% less than existing city household VMT per capita or regional household VMT per capita.

Given the proposed project's geographic location at the southerly edge of the City of Fortuna, it would likely have a VMT per capita greater than the City of Fortuna average. However, in a regional context, the proposed project site is closer to the urbanized portion of the City of Fortuna than most areas of the region. Therefore, the proposed project would likely have a lower than average VMT per capita in comparison to the regional average. Based on this qualitative analysis, VMT impacts are expected to be less than significant.

The Department finds there is no evidence that the project will exceed the level of service standard, will result in a change in air traffic patterns, will result in vehicle miles traveled beyond that expected, will result in inadequate emergency access, inadequate access to nearby uses or inadequate parking capacity; or will conflict with adopted policies supporting transportation.

Staff finds no evidence that the proposed project will significantly degrade the quality of the environment, nor will it have impacts that are individually limited but cumulatively considerable.
