Project Description: AltAir Paramount LLC (AltAir), formerly named Paramount Petroleum Corporation, operates a renewable fuel company which processes various bio-mass based feedstocks (e.g., non-edible vegetable oil, beef tallow, animal fats and greases) and refines them into bio-fuels such as diesel, jet and gasoline in accordance with a South Coast Air Quality Management District (South Coast AQMD) Title V facility permit (Facility ID No. 187165). AltAir submitted four applications to revise the Title V permit for its terminating operations. Application No. 609048 requested a permit revision to the Tank/Rail Car Loading/Unloading Facility to: 1) eliminate asphalt loading and fuel oil/asphalt loading while continuing to load distillate and caustic; 2) repurpose eight existing unloading arms to service renewable fuels and biofuels blending materials; 3) allow unloading of gasoline blend stocks (e.g. *iso*-octane denatured ethanol, alkylate, renewable naphtha); and 4) remove CECO Filters for asphalt loading and continue controlling the loading emission by an existing Incinerator System. Application No. 609050 requested a permit revision to storage tank T-50005 to change the commodities that can be stored to diesel, jet, renewable/bio diesel and jet fuels, to establish a new throughput limit of 300,000 barrels per month (bbl/month) and to modify the vapor control system. Application No. 609051 requested revisions to storage tank T-50006 to change the commodities that can be stored to diesel, jet, renewable/bio diesel and jet fuels, to establish a new throughput limit of 300,000 bbl/month and to modify the vapor control system. Application No. 609052 requested a new permit for previously exempt storage tank T-50008 to: 1) allow diesel, jet, renewable/bio diesel, jet fuels and gas oil to be stored; 2) establish a new throughput limit of 279,762 bbl/month; 3) install a geodesic dome cover; and 4) replace the foam log roof seals with a mechanical (metallic) shoe type primary seal and a wiper type secondary seal.

- City of Paramount Planning Commission Affidavit of Acceptance for Conditional Use Permit No. 751 - Paramount Petroleum Asphalt and Crude Terminal (July 10, 2013); and
- City of Paramount Addendum to Mitigated Negative Declaration & Initial Study for Conditional Use Permit No. 751 - Paramount Petroleum Biofuels and Petroleum Terminal (August 22, 2016).

This is to advise that the South Coast AQMD, as the Responsible Agency, has approved the above-described project on June 23, 2020 and has made the following determinations regarding the above-described project:

1. Prior to reaching a decision as part of this approval action, the South Coast AQMD, as Responsible Agency, has considered the aforementioned City of Paramount CEQA documents and supporting materials which concluded less than significant environmental effects. South Coast AQMD also considered and evaluated the application materials submitted by AltAir seeking revisions to their Title V permit. South Coast AQMD's review of the project concluded that the project has no potential to create significant adverse environmental effects.
2. The project will not have a significant effect on the environment.
3. Since no significant adverse environmental impacts were identified, mitigation measures were not required or made a condition of project approval.
4. A mitigation monitoring and reporting plan in accordance with CEQA Guidelines Section 15097(a) was not required or adopted for this project.
5. Findings were not required or made pursuant to CEQA Guidelines Section 15091 because the potential environmental impacts were not significant.
6. A Statement of Overriding Considerations pursuant to CEQA Guidelines Section 15093 was not required or adopted for this project because the potential environmental impacts were not significant.

Project Site: The project site is located at 14700 Downey Avenue in the City of Paramount.

Applicant: The Applicant is Paramount Petroleum Corporation (William Winters), 14700 Downey Avenue, Paramount, California, 90723.

Project Description: The Applicant, Paramount Petroleum, is requesting the City of Paramount consider the approval of a Conditional Use Permit (CUP 751) that would permit the construction and operation of a new asphalt and crude terminal within the existing Paramount Petroleum Refinery. The proposed improvements will modify the existing railway facilities to facilitate the import of asphalt and crude into the existing refinery facility. The imported asphalt will then be stored in existing above-ground storage tanks and subsequently blended and transferred into smaller tanks for sale to end users. Crude oil will continue to be processed as it has in the past with any additional processing of asphalt products taking place in the existing on-site manufacturing facilities. All of the modifications and new equipment would be located within four areas within the existing refinery and they would be related to upgrades to the existing truck and rail loading and loading facilities.

Determination: The City of Paramount, in its capacity as the Lead Agency, approved the above discretionary action on July 9, 2013 and has made the following determinations regarding the above described project:

- The project *will not* have a significant effect on the environment with the recommended mitigation.

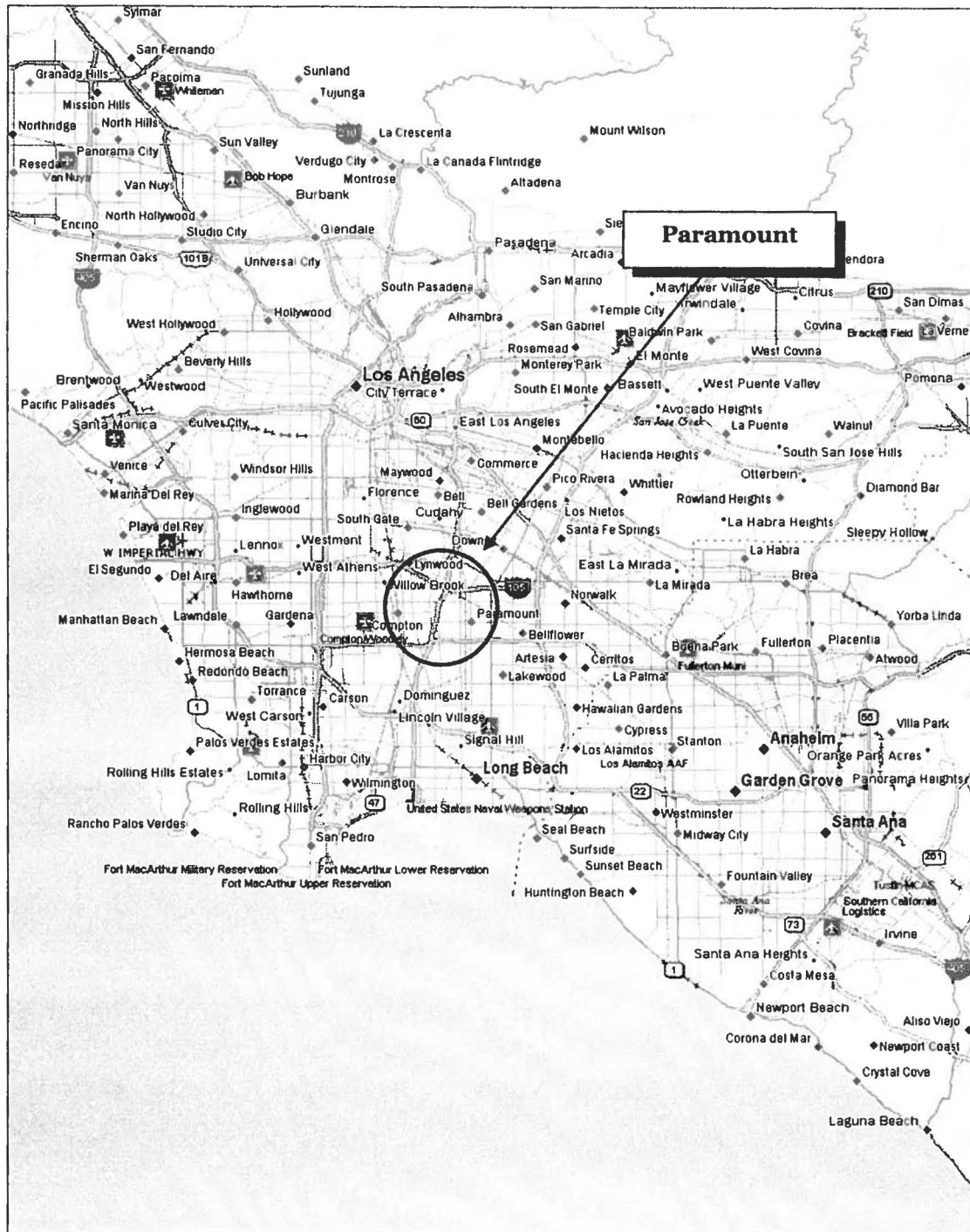


EXHIBIT 1

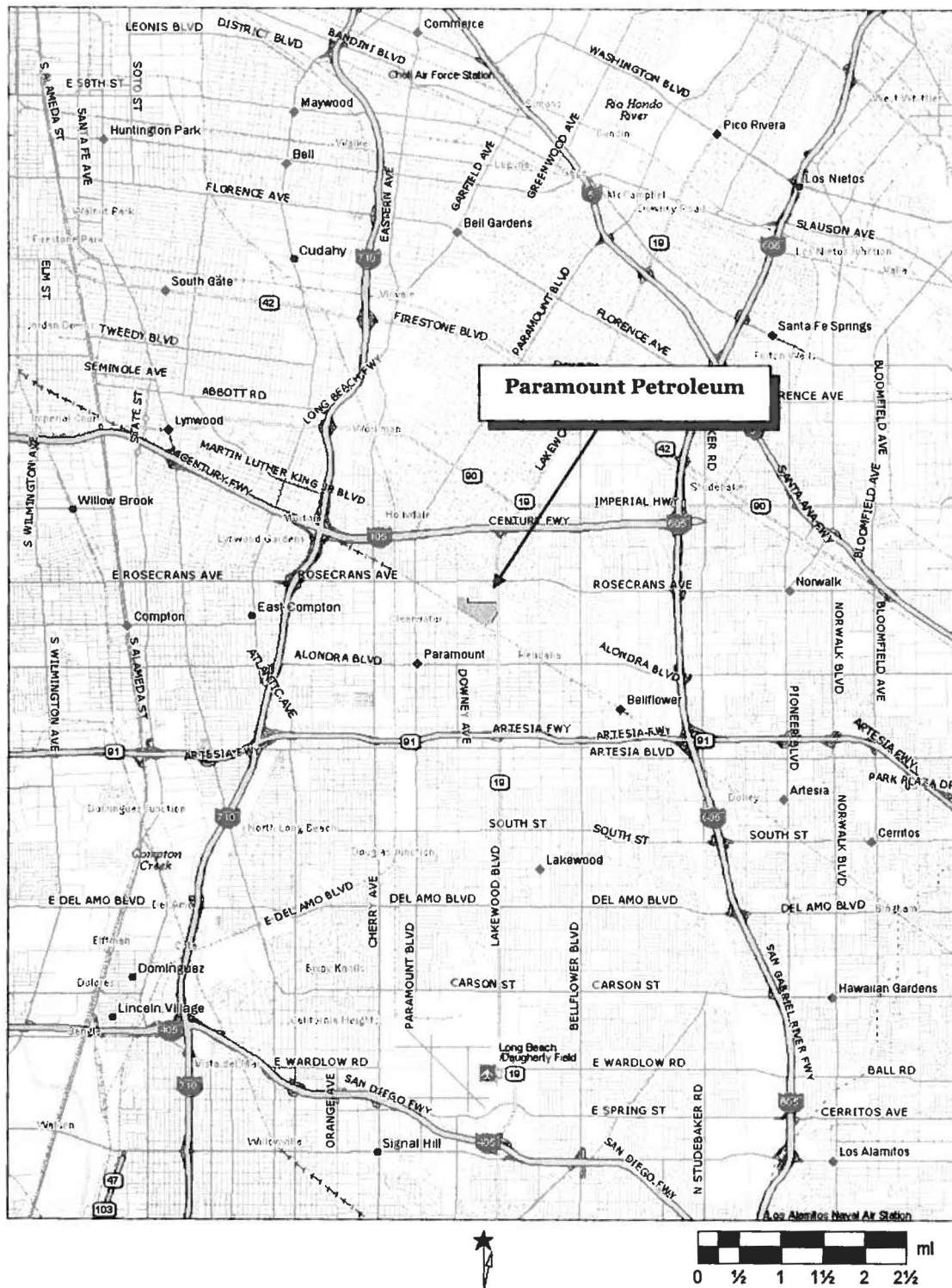

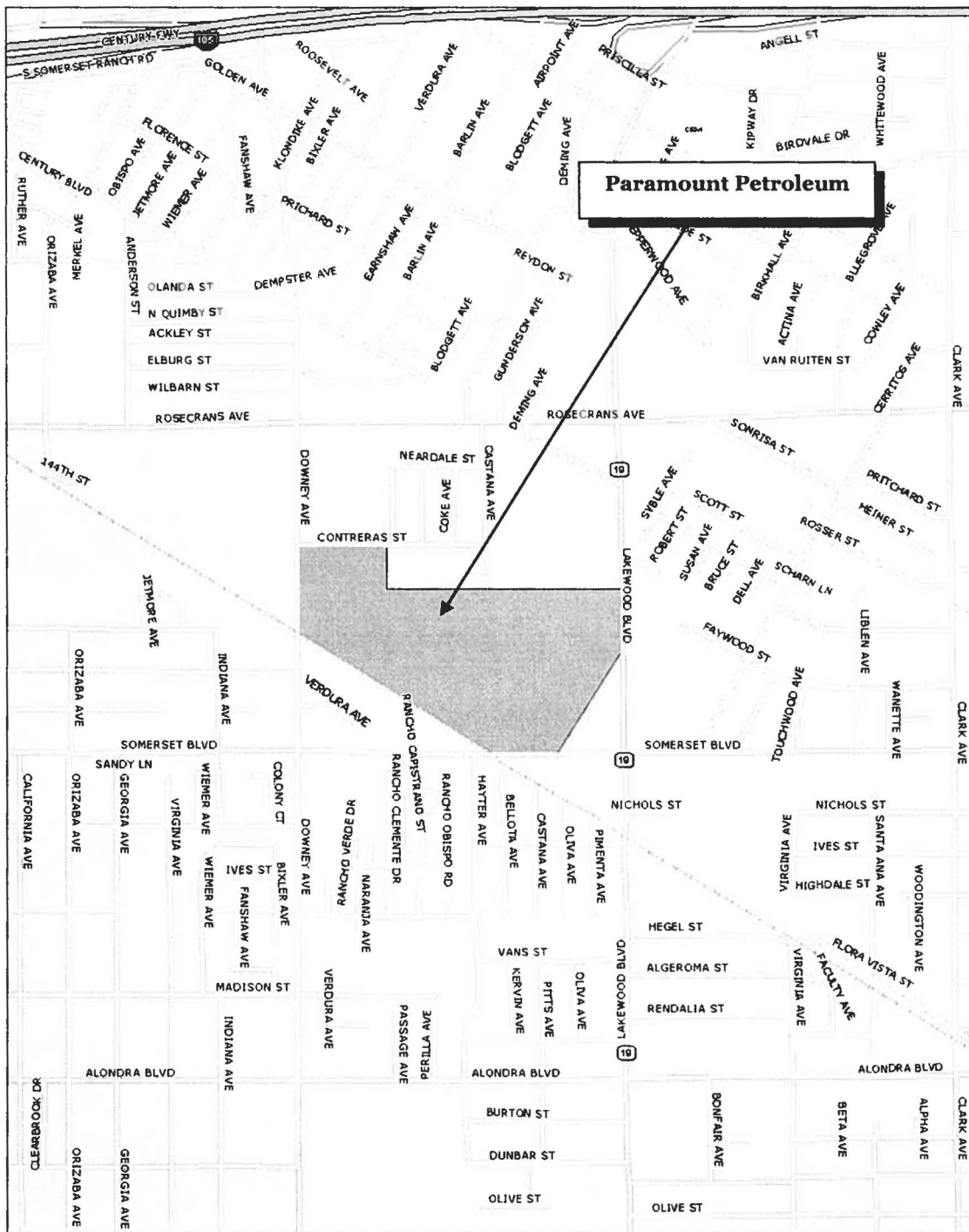
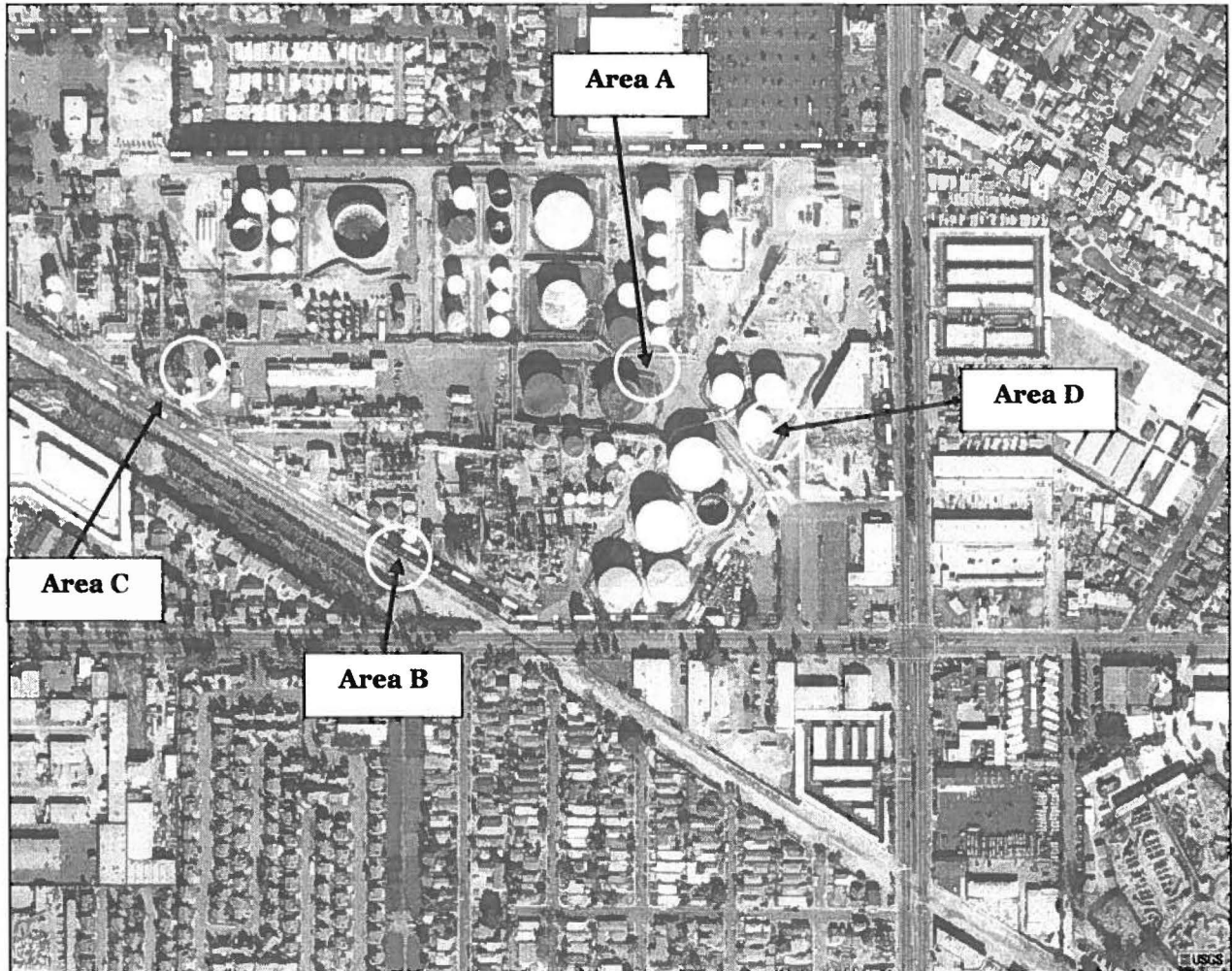

Brief Project Description: The proposed improvements will modify the existing railway facilities to facilitate the import of asphalt and crude into the existing refinery facility. . Area A. The proposed improvements in this area will involve the replacement of the existing platform and loading arm and the installation of 400-feet of steam traced and insulated piping. A new vapor recovery system and new spill containment will also be installed. . Area B. The proposed improvements include the installation of an unloading pump, steam traced and insulated piping, and unloading hoses. The existing steam delivery piping will be enlarged from 3 feet to 6 feet and the existing condensate return piping will be enlarged to 3 feet. The existing 8-inch vapor recovery header will also be extended. The existing platform located to the north of Track # 2 will be extended and a new spill containment trench will be constructed. . Area C. New rail unloading equipment will be installed at Rail Spur Track # 3 also located inside the refinery. This new unloading equipment will include the installation of an unloading pump, insulated piping, and steam tracing and unloading hoses. Area 4. The new equipment that will be installed includes a pump, insulated piping, and a steam tracing and unloading hose. Spill containment improvements will also be installed.

Determination: Based on a review of the project as proposed, the Department of Fish and Wildlife has determined that for purposes of the assessment of CEQA filing fees (Fish and Game Code [FGC] Section 711.4(c)) the project has no effect on fish, wildlife or their habitat and the project as described does not require payment of a CEQA filing fee. This determination does not in any way imply that the project is exempt from CEQA and does not determine the significance of any potential project effects evaluated pursuant to CEQA.


