Project Location (include county): The project is located in Humboldt County, on State Route (SR) 36 between post mile (PM) 11.3 to 34.6 across perennial tributaries within the Lower Eel Watershed. From U.S. Route 101 take the SR 36 East exit. Hely Creek Bridge is located on SR 36 approximately three miles east of the town of Carlotta at PM 11.46. Little Larabee Creek Bridge is located on SR 36 approximately fourteen miles east of Hely Creek at PM 25.27. Butte Creek Bridge is located on SR 36 approximately nine miles east of Little Larabee Creek at PM 34.52.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number EPIMS-HUM-25051-R1C, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Tariq Chechi, representing the California Department of Transportation (Caltrans).

The California Department of Transportation (Caltrans) proposes to upgrade bridge rails and shoulder widths of the Hely Creek Bridge, Little Larabee Creek Bridge and Butte Creek Bridge located at Post Miles (PMs) 11.46, 25.27, and 34.52, respectively. The existing bridges at Hely and Butte Creek would be replaced, and the bridge at Little Larabee Creek would be widened. The purpose of the project is to upgrade bridge rails to meet current design standards and improve shoulder widths.
