Comments received after the public comment period is closed shall not become part of the public record of the hearing and shall not be made available to the Development Advisory Board Members.

A PUBLIC HEARING HAS BEEN SCHEDULED BEFORE THE DEVELOPMENT ADVISORY COMMITTEE OF THE CITY OF FONTANA FOR THE FOLLOWING:

San Sevaine Trail, Segment 2

This Notice of Intent to Adopt is for the Initial Study / Mitigated Negation Declaration for the City of Fontana Engineering Department's San Sevaine Trail Project that would consist of the expansion of the existing Class I San Sevaine Trail, Segment 2, by adding a new 1.25-mile trail segment within the cities of Fontana and Rancho Cucamonga. The Project would involve converting an existing maintenance road, which currently runs parallel to the Etiwanda flood control channel, into a section of trail, and filling the gaps in the new linear path with a direct connection to the existing Pacific Electrical (PE) Trail. The proposed Project would also include the following improvements:

 Addition of a 12-foot wide asphalt path, narrowing to 8 to 10-feet in places, 2-foot shoulders, 4 benches, LED lighting, directional and interpretive signage, a chain link fence, potable water connection, and striping and pavement legends.

- Pavement of existing flat surface on the west side of Etiwanda Channel.
- Under bridge clearances on both the south and northbound I-15 undercrossing would require excavation and construction of retaining walls.
- Under bridge clearances on both the east and westbound SR-210 undercrossing would require excavation and construction of retaining walls.
- Installation of a signalized mid-block crossing to connect south across Victoria Street to the westbank of the Etiwanda Channel.

Environmental Determination: A Mitigated Negative Declaration (MND)/Initial Study has been prepared pursuant to Section 15070 of the California Environmental Quality Act (CEQA) and per Section 6.04 of the City of Fontana 2019 Local Guidelines for Implementing CEQA.

Location:

The proposed Project is located within the cities of Fontana and Rancho Cucamonga in southwestern San Bernardino County. The Project limits are from the Pacific Electric Inland Empire Trail in the City of Fontana to Banyan Street in the City of Rancho Cucamonga. Of the total 1.25-mile **Project** alignment approximately 0.30 miles are within Fontana's city limits approximately 0.95 miles are within Rancho Cucamonga's city limits.


