Project Description (Proposed actions, location, and/or consequences).

The Project site is situated at the northwest corner of Central Avenue and Sycamore Canyon Boulevard in the City of Riverside, on a single parcel: 256-050-012. The project consists of developing 9.44 acres with a multi-family residential complex containing a total of 237 one-, two-, and three-bedroom apartment units in seven buildings, consisting of five 3-story and two 2-4 story buildings. The project includes the following amenities: on site leasing office, garages, carports, mail lounge, putting green, outdoor resort style pool and spa, dog run area with a dog wash station, fitness center, clubhouse, shade structures with barbecues and tables, and a walking perimeter loop trail (1/2 mile loop) with learning or exercise stations.

The required approvals and entitlements include: General Plan Amendment, Zoning Code Amendment, Design Review, Variance, Grading Exceptions, Summary Vacation (to acquire excess City street right-of-way), and EIR.

Identify the project's signiifcant or potentially signiifcant effects and briefly describe any proposed mitigation measures that would reduce or avoid that effect.

Potentially significant impacts related to the following are analyzed in the EIR: Aesthetics, Air Quality, Biological Resources, Cultural Resources, Energy, Geology and Soils, Greenhouse Gas Emissions, Land Use and Planning, Noise, Transportation, Tribal Cultural Resources, Utilities and Service Systems, Fire Protection and Wildfire.

Mitigation measures include: photometric (lighting) plan, avoidance of nesting bird season and pre-construction nesting bird and burrowing owl surveys, temporary fencing and biological monitor during construction, temporary noise barrier, avoidance of the riparian plant community and wildlife corridor, archaeological and paleontological monitor, treatment and disposition of inadvertent discovery of archaeological or tribal cultural resources, cultural sensitivity training, deep dynamic compaction ground improvement, fair share contribution for intersection improvements, sidewalk connection, high visibility crosswalk with pedestrian signal on Central Avenue, ADA compliant bus turnout, install water and power supply prior to delivery of combustible building materials, fuel treatment zones, improved fire walls and sprinkler systems, use of non-combustible construction materials for non-habitable structures, and fire safety training for employees.
