The loss of invert has eroded the slope and undermined the base of a San Diego Gas & Electric utility pole. A temporary access road will be constructed just west of State right of way. The slope between the bridge (Bridge #57-0760) and the utility pole will be repaired. The vegetated area north of the damaged culvert will be used as a staging area. Hydroseeding will be applied to the project area upon completion. If there are any changes to the project location or work activities, Caltrans Environmental shall be contacted for further review.
