NOTICE OF INTENT TO ADOPT A
MITIGATED NEGATIVE DECLARATION

Notice is hereby given that the County of Fresno has prepared Initial Study Application (IS) No. 7029 pursuant to the requirements of the California Environmental Quality Act for the following proposed project:

INITIAL STUDY APPLICATION NO. 7029 and UNCLASSIFIED CUP APPLICATION NO. 3512 filed by GRANITE CONSTRUCTION COMPANY, proposing to allow the expansion of an existing aggregate mining operation on a 299.11-acre parcel in the AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District in the unincorporated area of the County of Fresno and on a 202.54-acre parcel in the MBL (Light Manufacturing/Business) Zone District in the City of Coalinga. The project site is located on the north side of Cambridge Avenue, between Monterey Avenue and State Route 198/33, adjacent to and within the city limits of the City of Coalinga (38940 Highway 33, Coalinga) (SUP. DIST. 4) (APN 070-060-86S, 89S). Adopt the Mitigated Negative Declaration prepared for Initial Study Application No. 7029, and take action on Unclassified CUP Application No. 3512 with Findings and Conditions.

(hereafter, the "Proposed Project")

The County of Fresno has determined that it is appropriate to adopt a Mitigated Negative Declaration for the Proposed Project. The purpose of this Notice is to (1) provide notice of the availability of IS Application No. 7029 and the draft Mitigated Negative Declaration, and request written comments thereon; and (2) provide notice of the public hearing regarding the Proposed Project.

The County of Fresno will receive written comments on the Proposed Project and Mitigated Negative Declaration from July 6, 2020 through August 6, 2020.
