**Description of Nature, Purpose, and Beneficiaries of Project:** *The proposed project would involve replacement of existing boilers and waste stack lines by Sheraton San Diego Hotel and Marina (Tenant) in the City of San Diego, California. Work to specifically complete the proposed project would include replacement of two (2) boiler units in the mechanical room and replacement of four (4)-inch waste stack pipelines within 18 guest bathrooms at the Sheraton Bay Tower building; no exterior work is proposed. Construction of the proposed project is anticipated to occur in Spring 2020 and would take approximately one (1) month to complete.*

*Due to its nature and limited scope, construction of the proposed project would generate a minor amount of vehicle trips and would require limited use of equipment. Therefore, significant impacts related to air quality, greenhouse gas emissions, and transportation and traffic are not anticipated to occur. Furthermore, the Tenant would be responsible for complying with all applicable federal, state, and local laws regarding construction demolition debris, hazards and hazardous materials, and stormwater.*
