PROJECT DESCRIPTION

THE REAL PROPERTY AND THE OWNER

The project is located at the CAL FIRE Ahwahnee Fire Station located at 43033 Highway 49 South, Ahwahnee, CA 93601. The property is characterized as oak woodland at 2,305 feet elevation with native/non-native grasses and forbs in a rural residential area. The project involves the installation of a DG60-2 Caterpillar generator to provide electrical power to the facility in the event of a power outage. A 16' x 10'concrete footing will be poured to provide a level foundation for the generator. Minor trenching will be completed at lineal distances of approximately 8 feet and at a depth of 30 inches to connect the existing propane line to the generator and then the generator to the station electrical system.
