Notice is hereby given that the City of Pleasanton, acting as Lead Agency under the California Environmental Quality Act (CEQA), is releasing for review and comment to all agencies, organizations and interested persons, a Draft Initial Study and Mitigated Negative Declaration (IS/MND) for the Pleasanton Stream Maintenance Project (Project).

Public Review Period: The Draft IS/MND is being circulated for a 30-day review period beginning July 10, 2020 to August 11, 2020 pursuant to Section 15105 of the CEQA Guidelines. Persons responding are urged to submit their comments in writing. Comments should be mailed or emailed to the City, at the addresses listed below, by no later than **3:30 p.m. on August 11, 2020**.




Figure 1. Project Area Location Map

Project Location: The proposed project site is comprised of 25 locations throughout the City of Pleasanton where maintenance will occur. The Assessor's Parcel Numbers (APN) for the project locations are found in the attachment 1 to this Notice. The project sites are accessed multiple local-serving roads, as depicted in Figure 1.

Project Description: The purpose of the proposed Project is to conduct maintenance activities in stream segments and stormwater detention ponds throughout the City of Pleasanton to improve stormwater conveyance and quality. This would be accomplished through maintenance activities such as weed abatement and silt and rock removal in seventeen stream sections and eight stormwater detention ponds throughout Pleasanton.

Public Hearing Dates: A public hearing date for the City of Pleasanton City Council to review the IS/MND and Project has been tentatively scheduled for **September 15, 2020 at 7pm**.

CEQA Project Status: A Draft Initial Study and Mitigated Negative Declaration have been prepared for this project pursuant to the provisions of CEQA. The Draft IS/MND prepared for this Project demonstrates that the Project will not have any significant or unmitigatable effects on the environment. As a result of the adoption of this document and the implementation of the proposed mitigation measures, the Project will not have any significant or unmitigatable effects on the environment.
