The project proposes to clean and seal the existing section of stamped concrete that is collecting material, excavate gore material, and place approximately 5,000 SF of minor concrete. The concrete will be placed along the driver's line of sight between the Central Avenue stop sign and vehicles exiting the freeway. The purpose of this project is to improve the sight distance at the intersection of SR 200, US 101 NB offramp, and Central Ave near Mckinleyville. All work would occur within the State right-of-way. Biological, cultural, visual, water quality, and hazardous materials reviews have been completed.
