Project Title: Streambed Maintenance (Streambed Alteration Agreement No. 1600-2018-0285-R2)

Project Location (include county): The project is located within the City of Jackson, Amador County, California. The maintenance work will cover approximately 4.75 miles of streams and drainage facilities (watercourses) within the Jackson Creek (1.9 miles), North Fork (1.45 miles), South Fork (0.9 miles), Sutter Street drainage (0.1 miles) and the Court Street drainage (0.4 miles).

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number 1600-2018-0285-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, City of Jackson.

The proposed project includes the routine maintenance of facilities including, vegetation control, invasive species removal, debris or obstruction removal, and sediment removal. The lack of performing these maintenance tasks could potentially adversely affect the natural flow or otherwise reduce channel capacity, accelerate erosion, or cause flooding into adjacent streets and structures thereby causing a public health and safety hazard.
