Purpose: The purpose of the project is to improve ride quality and preserve and extend life of the existing pavement.

Need: The deteriorating pavement is causing poor ride quality and needs frequent maintenance.

Program: This a Maintenance (HM) project under program code 20.80.110, and PMCS code HM1

#### **Biological Studies**:

In coordination with District Biological Studies, a Natural Environment Study (Minimal Impacts) (NES[MI]) was prepared and approved on July 24, 2020. The NES(MI) determined that the proposed project will have "No Effect" to any Federally-listed species or their habitat, pursuant to Section 7(a)(2) of the Federal Endangered Species Act and would result in "No Take: to any State-listed species or their habitat, pursuant to the California Endangered Species Act. Caltrans anticipates no regulatory permits.

- BIO-1: Environmentally Sensitive Area Designation and Delineation: shall determine the need for and placement of ESA fencing around areas that will be avoided by the project. No construction activities shall be allowed outside areas limited by the ESA fencing.
- BIO-2: Equipment Staging: Equipment, vehicles, and materials staging, and storage must be in previously paved or previously disturbed areas.
- BIO-3: **Pre-Construction Nesting Bird Survey**: If construction occurs during the nesting bird season (February 1 to September 30), A pre-construction survey will be conducted by a authorized biologist to determine the presence or absence of nesting birds within the BSA. The nesting bird survey will be conducted no more than three (3) days before start of work. The designated biologist will report the results of the survey to the Caltrans resident engineer. If an active avian nest is located, a 300 foot no construction buffer (500 foot for raptors) will be put in place until nesting has ceased or the young have fledged.

#### Cultural Studies: Section 106 Screened Undertaking:

In coordination with District Cultural Studies, a Cultural Resources Compliance Memorandum was prepared and approved April 30, 2020. The project as currently proposed has been determined as a screened undertaking, with no potential to affect historic properties eligible for or listed on the National Register of Historic Places. As a result, this project is exempt from further review and the Section 106 compliance process is complete, CEQA cultural resources component, and PRC 5024 compliance are complete. The provisions of the PRC 5024 MOU, Attachment 2 have been applied to this project. This project falls under: Class 1, "Pavement reconstruction, resurfacing, shoulder backing, or placement of seal coats," Class 4, "Establishment of chain control areas, park-and-ride lots, or maintenance pullouts," Class 5, "Minor modification of interchanges and realignments of on/off ramps," Class 7, "Installation of noise barriers or retaining walls," and Class 14, "Installation, removal or replacement of roadway markings,



such as painted stripes, raised pavement markers, thermoplastic tape, or raised bars, or installation of sensors in existing pavements."

- CR-1: If buried cultural resources are encountered during Project Activities, it is Caltrans policy that work stop within 60 feet of the area until a qualified archaeologist can evaluate the nature and significance of the find.
- CR-2: In the event that human remains are found, the county coroner shall be notified and ALL construction activities within 60 feet of the discovery shall stop. Pursuant to Public Resources Code Section 5097.98, if the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) who will then notify the Most Likely Descendent (MLD). The person who discovered the remains will contact the District 8 Division of Environmental Planning; Andrew Walters, DEBC: (909)383-2647 and Gary Jones, DNAC: (909)383-7505. Further provisions of PRC 5097.98 are to be followed as applicable.

#### Hazardous Waste:

In coordination with District Environmental Engineering, an Initial Site Assessment (ISA) Checklist was prepared and approved by District Environmental Engineering on July 21,2020. According to the ISA Checklist, the project's potential for hazardous waste involvement as "Minimal".

Hazardous Waste Environmental Commitments include: HW-1: Include SSP 7-1.02K (6)(j)(iii) for non-hazardous ADL.

#### Air Quality:

District Environmental Engineering provided a memorandum, May 18, 2020 stipulating that the project is exempt from all air emissions analysis, therefore the project does not require an Air Quality report.

#### Noise:

District Environmental Engineering provided a memorandum on May 22, 2020 and determined that this is a Type II project per Traffic Noise Analysis Protocol. Therefore, a noise study is not required.

#### **Paleontological Studies**:

In coordination with District Paleontology, it was determined July 21, 2020 no paleontological studies are required.

Changes to the project's scope of work (including any changes necessitated by utilities), limits, construction strategy and/or staging and storage requirements, and/or the timeframe of construction, as well as Final Design (PS&E) efforts not addressed during preliminary design (PA&ED), will require that the District's Division of Environmental Planning be notified in a timely manner, to determine if performance of an Environmental Re-Evaluation will be required—and to otherwise confirm that the environmental documentation for CEQA compliance remains valid. Updates to the original Technical Studies, or preparation of new Technical Studies may be required and/or new CE Determination Form may need to be completed, and/or an Environmental Document may need to be prepared and approved to document the project's compliance with all applicable CEQA requirements.



If an Environmental Reevaluation is determined to be necessary, it will need to be completed before the associated scope of work, or project limits or other change(s) being considered for the project, are implemented.

An Environmental Certification will be required at the end of the PS&E phase—prior to Ready-to-List.

The District's Division of Environmental Planning needs to be notified in a timely manner, if the project's scope of work, project limits, construction strategy and/or staging and storage requirements, and/or the timeframe of construction, changes during the Construction Phase, to determine if an Environmental Reevaluation (including possible updates to the original Technical Studies, or preparation of new Technical Studies) is required, and/or a new CE Determination Form may need to be completed, and/or an Environmental Document may need to be prepared and approved to document the project's compliance with all applicable CEQA requirements. If an Environmental Reevaluation is determined to be necessary, and/or additional analysis is required, all such efforts would be required to be completed before the scope of work (or project limits) change(s) being considered for the related portion of the project were implemented. Construction work consistent with the project scope included in the Environmental Certification issues for the project could continue, however, advance coordination with the Senior Environmental Planner assigned to this project would be necessary.

Completion of a Certificate of Environmental Compliance at Construction Contract Acceptance will be required following completion of construction of the project.

Completion of a Certificate of Environmental Compliance is required prior to project close-out.
