# NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION MONTEREY COUNTY PLANNING COMMISSION

NOTICE IS HEREBY GIVEN that Monterey County Resource Management Agency (RMA)-Planning has prepared a draft Mitigated Negative Declaration, pursuant to the requirements of the California Environmental Quality Act (CEQA), for a Combined Development Permit (Auerbach; RMA-Planning File No. PLN190276) located at 2700 Red Wolf Drive, Carmel, Carmel Area Land Use Plan (Assessor's Parcel Number 416-011-004-000) (see description below).

The Monterey County Planning Commission will consider this proposal at a public hearing on a future date to be determined, in the Monterey County Board of Supervisors Chambers, 168 West Alisal, 2<sup>nd</sup> Floor, Salinas, California. Written comments on this Mitigated Negative Declaration will be accepted from **August 6**, 2020 to **September 8**, 2020. Comments may also be made during the public hearing.

**Project Description:** Combined Development Permit consisting of a Coastal Administrative Permit and Design Approval to allow construction of a 5,588 square foot three-story single-family dwelling with an attached 564 square foot garage, including installation of an on-site wastewater treatment system, installation of a 2,000 square foot ground-mounted photovoltaic system, conversion of a test well to a permanent domestic well, and associated grading of approximately 1,914 cubic yards of cut and fill; Coastal Administrative Permit and Design Approval to allow construction of a 425 square foot detached guesthouse; Coastal Development Permit to allow removal of six trees (Monterey pine); Coastal Development Permit to allow development on slope exceeding 30 percent; and after-the-fact Coastal Development Permit to allow development within 100 feet of environmentally sensitive habitat area.

We welcome your comments during the 30-day public review period. You may submit your comments in hard copy to the name and address above. The RMA also accepts comments via e-mail or facsimile but requests that you follow these instructions to ensure that the RMA has received your comments.
