Parks and Recreation to RL-2, Single Family Low Density Residential, Vesting Tentative Map, Design Review to construct the Richmond Country Club Residential Project, a 94-lot residential subdivision, consisting of detached single family homes and related improvements at Markovich Lane. The project is generally bounded by a branch of the AT&SF Railroad to the west and Richmond Country Club golf course is located to the east (APNs: 405-050-006 AND 405-050-019).
